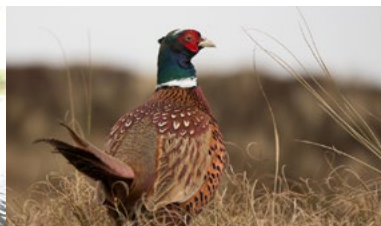
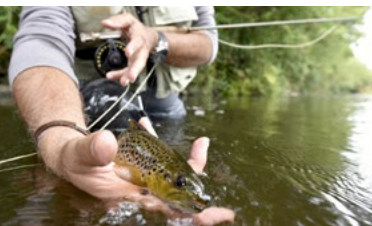

IFA Countryside members who have attained the age of 18 years and not attained the age of 75 years are covered if they are unfortunate enough to sustain bodily injury arising in a personal capacity.
