Personal Legal Liability Cover

As an IFA Countryside member, you are covered for personal legal liability in respect of an injury to any third party person or damage to third party property of up to €6.5m for any occurrence caused by accidental fault or negligence of the insured in a private capacity.

Personal Accident Cover

IFA Countryside members who have attained the age of 18 years and not attained the age of 78 years are covered if they are unfortunate enough to sustain bodily injury arising in a personal capacity.

Loss or Damage to Licensed Firearms

Cover applies in connection with fire or theft only, while your licensed firearm is away from the private dwelling house. One claim per year up to €500.
